

## Official Rules 3-Step Winter Prep Sweepstakes Sponsored by Power Service Products

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

- 1. <u>Sponsor</u>: The Sponsor of the 3-Step Winter Prep Sweepstakes (the "**Sweepstakes**") is Power Service Products, Inc. ("**Power Service Products**") P.O. Box 1089, Weatherford, TX 76086 US.
- 2. <u>Eligibility</u>: This Sweepstakes is open only to legal residents of the United States and Canada (excluding Quebec) who are 18 years or older as of the date of entry. Residents of Quebec are not eligible to enter or win. Employees of Power Service Products, its affiliates, subsidiaries, advertising and promotion agencies, and suppliers (collectively the "Employees"), and immediate family members and/or those living in the same household of Employees are not eligible to participate in the Sweepstakes. - 4. <u>Sweepstakes Period</u>: Entries will be accepted online starting on **October 15, 2021, at 8am CT** and ending **November 15, 2021, at 8pm CT**. All entries must be received by November 15, 2021, at 8pm CT.
- 5. <u>How to Enter</u>: As a Contestant, You must enter the Sweepstakes by filling out the entry form provided on the powerservice.com/winter-prep web page. You must provide the information requested which includes your name, contact information, vehicle fuel tank capacity, and (optionally) vehicle type. Entries that are incomplete or do not adhere to the Official Rules or entry specifications may be disqualified at the sole discretion of Power Service Products. You may enter only once. Mailed entries or entries received in any manner other than the specified online entry form will be disqualified.
